**Quarantine must begin no later than August 24th, 2020**

## Covid-19 & International Travel & Mandatory Quarantine

A warm welcome to our student-athletes who will join our on campus living program for the 2020/21 academic year! We are thrilled to have you as part of our new campus and are looking forward to beginning the school year with you. To begin this year with a quarantine is not what any of us had anticipated. We are working with our local health authorities to oversee the transition and understand that some of these measures may seem overwhelming and unfamiliar. We are taking every step to ensure a safe and comfortable transition to school. Please be proactive and do your part before arriving on campus. We are asking that you begin your own **quarantine and participate in social distancing beginning August 10th.** Thank you for your understanding, patience and commitment in ensuring this process runs smoothly.

### Arrival to Canada:

- Under the [Quarantine Act](#), put in place by the Government of Canada, it is mandatory for all travellers arriving in Canada to quarantine for 14 days.
- Residence move in day: September 7th, 2020; quarantine must begin no later than **August 24th, 2020. Please forward your travel plans/arrival time/and Point of entry to [cindy@thehillacademy.com](mailto:cindy@thehillacademy.com)** to receive a room allocation (room allocation to remain the same for remainder of school year).
- Quarantine will be held on campus and will be supervised by Hill Dons and Staff in a sectioned off portion of the dormitory.
- Students will be transported from their point of entry (airport, border) by a Hill staff member. Students must wear a mask while in transit, and car windows are to remain open at all times (regardless of the weather). Please send travel arrangements to Cindy to arrange pick-up.

### Daily Symptoms Screening:

- Within 48 hours of arrival, students must check-in through the [ArriveCAN app](#) or call 1-833-641-0343.
  - Students will report their symptoms through ArriveCAN app, or online or by calling 1-833-641-0343 every day until the end of the 14-day quarantine.
  - Students will monitor their symptoms for 14 days and if they experience symptoms (e.g. cough, shortness of breath, fever) must isolate themselves from others and inform the staff member on duty. Staff will then contact parents and Peel Public Health for further instructions. (1-866-797-0000)

- The quarantine period will be extended to 14 days following the onset of symptoms.

### On Campus Quarantine:



- Students will be allowed to congregate outside their dorm rooms in designated areas with other Quarantining students, however, masks must be worn and social distancing must be adhered to.
- Students can only use the bathrooms attached to their dormitory rooms.
- Students are not permitted to be in another student's dorm room during the quarantine period.
- Dorm rooms will be sanitized and cleaned prior to arrival, with students being responsible to keep the rooms clean and sanitized during the quarantine (supplies will be provided).
- Students are encouraged to wash hands frequently, use sanitizer, avoid touching their face, and cover their mouth and nose with their arm when coughing or sneezing.
- Students are **only** permitted to leave the quarantine location in order to seek medical assistance. Violators may be subject to fines implemented by the Public Health Agency of Canada if this is not followed.

#### Move In Procedures:

- A fee of \$650 will need to be collected prior to quarantine. This fee will cover the cost of all meals for the 14 days, the cost of House Dons and Staff to be on site, as well as for professional cleaning crews, and transportation to the school. - Please notify [lunch@thehillacademy.com](mailto:lunch@thehillacademy.com) of any food allergies or dietary concerns. All efforts will be made to accommodate these concerns with our catering company.
- Upon moving into the dormitories students will need to complete the room inspection check-list.
- Prior to moving day please electronically sign the On Campus Living Contract as well as **appendix forms C, D, E, F.** Email to [cindy@thehillacademy.com](mailto:cindy@thehillacademy.com)
- Students found breaking our quarantine rules may be asked to self-quarantine off-site at their own expense or may be sent home.
- The 14-day period starts again if, during the quarantine period, any signs and symptoms of COVID-19 develop.
- Under these unprecedented circumstances, our focus with the on-campus quarantine is risk mitigation for COVID-19; following the protocols put in place by the Government of Canada. We will do everything we can to create a warm and comfortable environment for the students. As it is a quarantine, the students will have a lot of downtime in their own rooms. It is highly recommended that the students come prepared with books, podcasts, and other activities that can be performed within their own room.
